As mentioned in the Tender notice in the local newspaper for "Outsourcing of Manpower" pre bid meeting held on 09.10.2017. During the pre bid meeting different queries made by the "Outsourcing of Manpower". In the light of queries following decisions have been taken.

1.	TIIPL, Patna	A) Clarify the mode of payment on A/C of Tender cost & EMD through NEFT or Bank Draft.	Tender money and EMD can be deposited through NEFT and Bank Draft both. In case of deposit through NEFT agency require to produce URN of the Bank.
		B) Soceity Act registered firm can participate or not.	It is hereby clarified that eligibility criteria is same as mentioned in the RFP.
		C) 50 Lakhs Annual turnover mentioned in page no.-3 of RFP where as in page no.-14 (11) average turnover mentioned "must be more than Rs. 10 lakhs".	It is hereby clarified that annual turnover is Rs. 50 lakhs as mentioned in RFP page no.-3. RFP page no.-14(11) may be read Rs. 50 lakhs in place of Rs. 10 lakhs.
		D) Please clarify RFP page no.-22(c) "Payable by SFC".	Payable by SFC is the gross total amount payable by SFC to the manpower agency. For example, if the net payable in hand salary (mentionable in H column) to an employee is 10,000/- relevant statutory deductions (mentionable in G column) are 3,000/-, then the cost to manpower agency (mentionable in F column) will be 13,000/-. Suppose agency service charge(mentionable in E column) thereon is 2,000/- and GST (mentionable in D column) is 2,700/- then the total cost payable by SFC(mentionable in C column) will be Rs. 17,700/-.
		E) Please clarify the BSFCSCCL remuneration as mentioned in RFP page no.-5(15).	Clause no. 15 at page no. 5 shall be replaced with the following clause : "The remuneration payable by the selected agency in due consideration


