A supplementary counter affidavit has been filed on behalf of the Additional Director General, Criminal. Investigation Department, Bihar, Patna.

Regard may be had to the observation made by this Court in the order, dated 09.05.2017, wherein it was hoped that the Director General of Police, Bihar, shall be looking into the request of the Additional Director General, Criminal Investigation Department, Bihar, Patna, for making available few police officers of the rank of Inspector of Police for expediting investigation.

It has been stated in the present supplementary counter affidavit that the Police Headquarters have issued order transferring 20 Police Officers of the rank of Inspector

of Police/Sub-Inspector of Police to Kaimur (Bhabhua) and the Inspector General of Police, Darbhanga Range, Darbhanga, has issued order for deputation of 10 Police Officers in the district of Kaimur.

The supplementary counter affidavit, which has been filed today, shows that the S.I.T. is taking sincere efforts to conclude the investigation expeditiously and effectively with all sincerity.

Mr. Anjani Kumar, learned Senior Counsel, assisting this Court, has drawn my attention to an order passed by the Supreme Court, dated 28.02.2017, passed in Special leave to Appeal (Criminal) No. 1779 of 2016 (State of Bihar v. Divesh Kumar Chaudhary and Another) and other analogous cases and has submitted that the condition put by this Court in several cases for grant of anticipatory bail/regular bail have been modified with an observation that the accused persons should ensure that bank guarantee, if not furnished, is furnished and if lapsed, is renewed, within a period of one month from the date of passing of the order, failing which the anticipatory bail/regular bail granted to them will stand cancelled.

It is up to the investigating agency to see as to in how many cases the said order has been complied with and in how many cases, the accused persons have not

furnished the bank guarantee in compliance of the Supreme Court's order and proceed accordingly thereafter. (
